The annual registration fee is \$5.00 per vehicle the applicant intends to operate within the borders of the State of Montana under Class A or D authority issued by the Commission. This fee does not apply to vehicles maintained and used as standby or emergency equipment. Mont. Code Ann. § 69-12-421(2)(b).

- Please check here if you only engage in seasonal transportation (i.e., operations that do not extend continuously over a period of more than 6 months in any calendar year). If so, your annual registration fee is \$2.50 per vehicle. Mont. Code Ann. § 69-12-421(2)(a).
- Please check here if your application includes a late fee.
